Sir,

This is regarding the request of the university for 12B Certificate.

In this regard, it may kindly be noted that UGC vide letter No. F.1-6/2023 (CPP-I/PU) dated 11.09.2024 had issued a letter to university (superseding earlier letter of even no. dated 04.06.2024), wherein university was intimated about its categorisation as Category-I as per the "UGC (Categorisation of universities (only) for grant of graded autonomy) Regulations, 2018". A copy of letter dated 11.09.2024 is attached for ready reference.

Vide this letter it was also intimated that **"The university shall now be eligible for the benefits as stipulated under Clause-4 (Dimensions of Autonomy of Category-I Universities) of the UGC Regulations. However, the privileges and benefits under the category will be regulated as per conditions given under Clause 6 (change in Category of University for non-maintenance of accreditation score or ranking as define in clause 3)".**

The Clause 4.1 under the heading "Dimensions of Autonomy of Category-I Universities" of the "UGC (Categorisation of universities (only) for grant of graded autonomy) Regulations, 2018" reads as under:

"4.1 Universities shall be automatically deemed to be under section 12B of the University Grants Commission Act, 1956 and no inspection by the Commission shall be required for the same".

In view of above, it is clarified that there is no need for a separate letter or certificate for 12B status as long as your university remains under Category-I.
